General Payment Methods

Payment by Credit Card

1. BESTSECRET accepts payment by credit card. The payment is processed by an external payment service provider. After entering the credit card details, an additional confirmation screen from the bank is displayed with all the payment details. You must go through the respective authentication procedure of your bank and can then confirm the credit card payment by entering a security code. For more information on the authentication procedure, please contact your bank. When paying by credit card, you can save the card information for the next payment. You can delete saved card

information at any time in the checkout process on the selection page for payment methods. You are liable for any additional costs incurred due to your fault when using the selected payment method, for example due to chargebacks. In the case of payment by credit card, the purchase price will be debited by BESTSECRET after receipt of the order.

- 2. Via the payment service provider Adyen N.V, Rokin 49, 1012 KK, Amsterdam, Netherlands (hereinafter "Adyen") you can use the payment option payment by credit card (Mastercard, VISA, American Express, Diners, Discover, maestro, card bancaire) at BESTSECRET. When you pay by credit card (Mastercard, VISA, American Express), Adyen generally receives your name, address, bank details, card information (i.e. card number, month of validity, year of validity, system/issuer) and information about your transaction (i.e. transaction number, currency, country of issuer, transaction date, transaction amount) as well as technical information such as browser information, risk data, shopperID. - 3. You can also pay by credit card (Mastercard, VISA, American Express) via the payment service provider Bambora AB, Vasagatan 16, 111 20 Stockholm, Sweden (hereinafter "Bambora"). As part of the payment process, your personal data will be transmitted to Bambora. Your data will only be passed on for the purpose of payment processing with Bambora and only to the extent that it is necessary for this purpose. Bambora collects and stores the data, also for the purpose of identity and credit checks, and passes it on to the respective credit card companies. However, BESTSECRET does not store your payment data. In the case of credit card payments (Mastercard, VISA, American Express, Diners), Bambora generally receives your name, address, bank details, card information (i.e. card number, month of validity, year of validity, system/issuer) and information about your transaction (i.e. transaction number, currency, country of issuer, transaction date, transaction amount) as well as technical information such as session ID, user ID and authentication information. Payment via PayPal

- 1. You can use the payment option PayPal at BESTSECRET via the payment service provider Braintree. PayPal is an online payment service provider that processes payments via so-called PayPal accounts, which are virtual private or business accounts. The European operating company of PayPal is PayPal (Europe) S.à.r.l. & Cie. S.C.A., 22-24 Boulevard Royal, 2449 Luxembourg, Luxembourg. Braintree is a service of PayPal (Europe) S.à r.l. et Cie, S.C.A..
- 2. If you select the PayPal payment method, you will be automatically redirected to the PayPal page at the end of the order process. There you can register and follow the PayPal payment instructions. In the case of payment via PayPal, the purchase price will be debited by BESTSECRET after receipt of the order. The PayPal account will be debited directly with the corresponding purchase amount.
- 3. As part of the payment process, your personal data will be transmitted to PayPal and Braintree. When paying via PayPal, PayPal and Braintree usually receive your first name, surname, address, email address, IP address, telephone number, mobile phone number or other data required for payment processing. Personal data relating to the respective order is also required to process the purchase contract.
- 4. The personal data transmitted to PayPal may be transmitted by PayPal to credit agencies. The purpose of this transmission is to check identity and creditworthiness. PayPal may pass on the personal data to affiliated companies and service providers or subcontractors if this is necessary to fulfil contractual obligations or if the data is to be processed on behalf of PayPal. ApplePay

ApplePay is a payment service provided by Apple Inc, 1 Infinite Loop, Cupertino, California 95014, USA. If you use Apple Pay, you pay directly via your Apple account. After submitting your order, you will be redirected to Apple. There you can authorise payment of the order amount. As soon as BESTSECRET has been informed of your authorisation, your order will be processed. Depending on the payment method stored with ApplePay, this will be debited with the actual invoice amount after deduction of any discounts, gift vouchers etc. immediately after authorisation. Payment as purchase on account or SEPA direct debit

- 1. Via the payment service provider Riverty GmbH, Gütersloher Str. 123, 33415 Verl/Germany (formerly Arvato Payment Solutions GmbH) (hereinafter "**Riverty**") you can use the payment options purchase on account and SEPA direct debit in some countries.
- 2. If you decide to pay with a Riverty payment method, Riverty will take over the entire processing of your payment transactions for BESTSECRET. You will already be informed here that if you choose a Riverty payment method, the claim arising from the respective purchase will be assigned to Riverty and the outstanding invoice amount must therefore be paid to Riverty. You will receive all information about the invoice, such as due date or account information, from Riverty by e-mail if it concerns you. The Riverty payment methods are not available for all countries and offers and require, among other things, a successful credit check by Riverty. - 3. With the SEPA direct debit payment method, your money will be debited directly from your bank account by our payment service provider Riverty. The payment will be debited at the earliest on the next bank working day after receipt of the order. A bank working day may also be a public holiday. The advance notice period for a SEPA direct debit is one day and is given with the order confirmation. Cancellation of the SEPA mandate by the account holder prior to debiting must be communicated to BESTSECRET immediately. Any costs incurred in connection with invalid mandates for which you or the account holder are responsible shall be borne by you and the account holder.
- 4. As part of the payment process, your personal data will then be transmitted to Riverty. When you make a payment, Riverty generally receives your contact details (name, address, date of birth if applicable, e-mail address if applicable) as well as details of the items you have ordered (e.g. order value, product group, value of goods, enquiry channel and delivery method if applicable), which are necessary to process the payment via Riverty. Your data will only be passed on for the purpose of payment processing with Riverty and only to the extent that it is necessary for this purpose. Riverty also stores the data for the purpose of identity and credit checks for the purpose of active payment method control in order to be able to assess solvency as well as possible when granting payment methods with credit risk.
